In continuation to Govt. Order No. 232-HUD of 2014 dated 5.8.2014 Sanction is hereby accorded to the release of funds amounting to Rs. 256.25 lacs (Rupees two hundred fifty six lacs and twenty five thousands only) i.e Rs. 128.125 lacs each in favour of Commissioner, Municipal Corporation Srinagar /Jammu thereby making total releases to the tune of Rs. 512.50 lacs under the scheme Capital City Development Projects of urban Dev. Sector, to be utilised on approved ongoing projects/schemes only during year 2014-15

The Director finance, H&UDD shall draw the funds in advance from treasury through WDC Bills and place the same at the disposal of concerned corporation in the shape of hundies.

The release of funds is subject to the following conditions

:-

- The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities.
- The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- The funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- The funds shall not be utilized on clearance of any past liability, repair /renovation & Maintenance work.
- The implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- The expenditure shall commensurate with the physical progress achieved.
- All video /photographic evidence of works shall be maintained.

- The physical and financial progress report shall be furnished to the Admn. Deptt. well in time
- The implementing agency shall follow up the procedural mech. Of CAS – MIS System.
