Subject: Constitution of Municipal COVID-19 Awareness and Management Committees.

Government Order No. 139-JK(HUD) of 2020
D a t e d 15.04.2020

Sanction is hereby accorded to the constitution of Awareness and Monitoring Committees at the level of Municipal Bodies and Municipal wards to have in place the institutional/ administrative mechanism to curb the spread of COVID-19 and to generate awareness and monitoring of the effective implementation of the advisories/ policies/directions issued by the Ministry of Health, GoI and Ministry of Health Government of J&K from time to time.

These Committees shall have the following mandate

- i. Promoting universal usage of masks by every inhabitant of Municipal Bodies.
- ii. Awareness regarding promotion of social distancing, hand wash and general cleanliness.
- iii. Co-ordination with the District Administration regarding the identification, isolation and treatment of COVID-19 patients.
- iv. Assisting District Administration in effective care of special attention categories like elderly, disabled, pregnant ladies, chronically ill etc.
- v. To remove any misconception of misinformation in people's mind regarding COVID-19.
- vi. To sensitize general public about Dos and don'ts in prevention of COVID-19.

Municipality wise orders for the Committee shall be issued by the Commissioner/Director Urban, Local Bodies and Ward wise orders of the Committee shall be issued by the concerned Chief Executive Officers/ Executive Officers as the case may be.
