The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the approved schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (iv) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work and the works should not have been executed during last 5 years.
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such

- as SDRF/State Plan/District Plan/CSS/BADP/Flagship Programme or any other source.
- (vi) the funds so released shall not be available for any re-appropriation/diversion and the works should be executed on e-tendering mode.
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
- (x) the implementing agency shall ensure the submission of physical and financial progress report to the Admn. Deptt. well in time;
- (xi) the physical verification of the works be conducted by the Sr. officers hierarchy to ascertain ground existence, quality parameters and execution as per approved DPR/detailed estimates as well as benefit to the public.
