In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Showkat Ahmad Rather S/O Late Mohammad Sultan Rather(Ex-Helper) R/O Razwan Dangerpora, Budgam as Class-IV(Gang Coolie) in the pay Band of Rs. 4440-7440 with the Grade pay of Rs.1300/- in Drainage Circle, Srinagar Municipal Corporation in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The post of helper held by the deceased has to be abolished by the UEED Department in terms of standing orders, issued by the Government in this behalf.

The appointee shall report to the Commissioner Srinagar Municipal Corporation within a period of 21 days from the date of issuance of this order.

The appointee shall be allowed to join only after production of the following certificates in original:-

- i. Age and health Certificate.
- ii. Date of Birth Certificate.
- iii. Academic qualification certificate, if any.
- iv. Permanent Resident Certificate.
- v. Certificate from the General Manager DIC and Dy. Director Employment concerned to the effect that no loan under self-employment scheme has been taken by the appointee.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the ADGP/IGP (CID), to whom a reference shall be made by the Commissioner SMC.
