Sanction is accorded to the release of additional funds amounting to **Rs. 75.27 Lakh (Rupees Seventy Five lacs & Twenty Seven Thousand)** only in favour of Superintending Engineer Sewerage & Drainage Circle Jammu **under the scheme Emergent Public Demands of Drainage Sector - State Capex Budget 2017-18** for its further placement at the disposal of Executive Engineer S & D Division West Jammu under Drainage Sector to be utilized for clearance of workdone liability of the ongoing/approved Drainage schemes during Current Financial Year.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii. The implementing agency shall ensure that the liabilities are legitimate and the work for which liabilities were incurred was/is part of a approved DPR, executed under proper authority and after observing all codal requisite formalities and due procedures and also ensure that the work has not been billed and / or paid for under any state /central or other schemes earlier;
- iii. The priority must be given to the works which are nearing completion and HCMs commitments shall be first charge over the current releases.
- iv. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- v. The funds shall be utilized on the approved components of the project/ schemes only and no new work/scheme shall be taken up without the approval of the competent authority;
- vi. The implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source;
- vii. The funds so released shall not be available for any re-appropriation/diversion;
- viii. The expenditure shall commensurate with the physical progress achieved;
- ix. All video graphic/photographic evidence of works both shall be maintained;

- x. The physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xi. No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
