The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP or any other source;
- (ii) the funds so released shall be utilized for proper purpose and not to be benefited to any individual;
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

- (v) the funds so released shall not be available for any re-appropriation/diversion;
- (vi) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
