Sanction is hereby accorded to the release of funds to the tune of **Rs. 50.00 Lakh (Rupees Fifty Lacs)** only in favour of **Project Officer, Charar-i-Sharief Dev. Project** under the scheme Urban Development Sector as an additionality authorized by the Planning Development & Monitoring Department in the Revised Estimates of State Capex Budget 2017-18 to be utilized for "**Renovation/Restoration of Bada Talab at Shrine of Sheikh Noor-ud-Din Noorani (RA) Charar-i-Sharief**" during current financial year 2017-18.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- (iii) the funds shall not be utilized on clearance of any past liability, repair, renovation and maintenance work and there shall be no expenditure on Revenue or Revenue like items;
- (iv) the Chief Project Officer, Charar-i-Sharief Development Project shall ensure that the funds shall be utilized for approved components of the project;
- (v) the implementing shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. Etc.;
- (vi) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vii) the funds so released shall not be available for any re-appropriation any diversion from one component to another component.

- (viii) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained;
- (ix) the Utilization Certificates for the released amount shall be submitted well in time;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against revised cost which has not been approved by the Competent Authority.
