Sanction is here by accorded to the release of **Rs. 10.00 lacs (Rupees Ten lac)** only in favour of Superintending Engineer Drainage Circle SMC as an additionality under State Capex Budget 2017-18 Drainage Sector for its further placement at the disposal of Executive Engineer concerned to be utilized for **Construction of CC drain including manholes at Hamdanyia Colony Sector-A Lane No. 5 and Constt. of CClateral Drain including manholes in the premises of Shafaqat Rehabilitation Centre Bemina Bye Pass Length 182 Mtrs** during the current financial year 2017-18 .

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- (iii) The implementing agency shall ensure that the liabilities are legitimate and the work for which liabilities were incurred was/is part of a approved DPR, executed under proper authority and after observing all codal requisite formalities and due procedures and also ensure that the work has not been billed and / or paid for under any state /central or other schemes earlier.
- (iv) the implementing shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. Etc.;
- (v) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) the funds so released shall not be available for any re-appropriation any diversion from one component to another component;
- (vii) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained;

- (viii) the Utilization Certificates for the released amount shall be submitted well in time;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) no expenditure shall be incurred against revised cost which has not been approved by the Competent Authority.


