Consequent upon the withdrawal of Rs. 22.50 lacs from PWD(R&B) Department by the Planning Development & Monitoring Department vide Govt. Order No 122-PD of 2018 Dated 29.03.2018 and subsequent release of the same to H&UDD, sanction is hereby accorded to the release of **Rs. 22.50 lacs (Rupees Twenty Two lacs & Fifty thousand)** only in favour of Superintending Engineer Drainage Circle JMC for its further placement at the disposal of Executive Engineer concerned to be utilized for execution/completion of the Upgradation of lane No. 22 connecting Greater Kailash and Sainik Colony during the current financial year 2017-18 .

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- (iii) the implementing shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. Etc.;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (v) the funds so released shall not be available for any re-appropriation any diversion from one component to another component;

- (vi) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained;
- (vii) the Utilization Certificates for the released amount shall be submitted well in time;
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (ix) no expenditure shall be incurred against revised cost which has not been approved by the Competent Authority.
