The release & subsequent utilization of funds is subject to the following conditions that:-

- i. **The implementing shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. Etc.**
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds so released shall not be available for any re-appropriation/diversion;
- v. the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- vi. the Utilization Certificates for the released amount shall be submitted well in time;



- vii. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- viii. no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.


