Subject:- SWP No: 1059/2017 titled Mohammad Asrar Qureshi versus State and Ors.

Government Order No: 14 HUD of 2018

Whereas, the petitioner namely Mr. Mohammad Asrar Qureshi was appointed as Junior Engineer (Electrical) vide Order No. DLB/Estt/239 of 2002 dated 02.08.2002 issued by the Directorate of Urban Local Bodies, Kashmir with a view to maintain the electric works including street lights in different Towns and was posted in Municipal Committee Baramulla;

Whereas, Mr Qureshi has represented before the Director, Urban Local Bodies, Kashmir for his placement on next grade as Assistant Engineer (Electric);

Whereas, the Director, Urban local Bodies, Kashmir vide his letter dated 12.02.2014, forwarded a copy of said representation of Mr. Mohammad Asrar Qureshi to this department for consideration on its merits;

Whereas, in the re-organization/Staffing pattern for Urban Local Bodies sanctioned vide Government Order No. 214-HUD of 2008 dated 27.05.2008 posts of Junior Engineers (Electrical) have not been provided for any Municipal institutions, however 17 posts of Junior Engineers (Civil) are sanctioned for engineering Division of Urban Local Bodies, Kashmir alongwith four posts of AEs and two posts of AEEs (Civil);

Whereas, the issue of re-organization of Engineering wing of Directorate Local Bodies, Jammu/ Kashmir has been discussed in the Administrative department several time and both Directorates have been advised to furnish the comprehensive proposal with respect of creation of Engineering Staff in their Directorate;

Whereas, the Director Urban Local Bodies, Kashmir has submitted a comprehensive proposal for re-organization of the Engineering Wing vide his letter NO. DULB/Estt/1485-11/23330 dated 11.11.2017; and

Now, therefore, the case of the petitioner was examined in Housing & Urban Development Department in light of the directions issued by the Hon'ble High Court vide Order dated 07.06.2017 in SWP No:-1059/2017 titled Mohammad Asrar Qureshi Versus State and Ors, it has been found that the claim of the petitioner is not covered under present Recruitment Rules of Urban Local Bodies 2008. However, the proposal with respect of creation of Engineering Staff including Electrical wing submitted by Director, Urban Local Bodies Kashmir vide his letter No. DULB/Estt/ 1485-11/23330 dated 11.11.2017 is under consideration with the Department and will be decided on its merits.
