Sanction is accorded to the release of Rs. 2.365 crores (**Rupees Two Crore Thirty Six And Fifty Thousands**) only in favour of **Mission Director Atal Mission for Rejuvenation and Urban Transformation (AMRUT)** as 50% of approved Central assistance for Administrative & Other Expenses (A&OE) component under AMRUT for the year 2016-17.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same in the official Bank Account bearing No. **0110040500000061** of Mission Director AMRUT maintained in the J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized for Administrative & Other Expenses (A&OE) component strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the expenditure shall commensurate with the physical progress achieved;
- (v) the Director Finance H&UDD shall vouchsafe the utilization of funds as per codal procedure/GOI's guidelines;
