- viii. the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- ix. the funds so released shall not be available for any re-appropriation/diversion;
- xiii) all video graphic/photographic evidence of works both shall be maintained;
- xiv) the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xv) no expenditure shall be incurred against revised cost which has not been approved by the competent authority.


