2. The concerned HOD/DDO is advised to incur the expenditure on authorized and permissible objects of expenditure only, after observing all codal formalities required under rules and no diversion of funds shall be permissible.
3. The expenditure shall strictly be incurred for the purpose for which the fund under GIA has been sanctioned/ released.
