- There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
- 3. The controlling officers shall be duty bound to ensure submission of revenue and expenditure statements to this Department on monthly basis.
- 4. The Controlling Officers/DDO's shall conduct periodic reconciliation of remittances and drawals with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
- The utilization certificates/Red Accounts of previous drawals have been rendered to the concerned quarter without any delay.
- 6. The Controlling Officers shall strictly inspect and supervise the public receipts and expenditure with reference to the Appropriation Act 2015 and all the standing rules and regulations.
