The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) **the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source.**
- (ii) **The works shall be put to e-tendering before execution**
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (v) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work;

- (vi) the funds so released shall not be available for any re-appropriation/diversion at any level;
- (vii) there shall be absolutely no scope for cost overrun and it shall be ensured that the works are taken up and completed within the approved cost only.
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) all video graphic/photographic evidence of works both shall be maintained;
- (x) the physical and financial progress report alongwith Utilization Certificate shall be furnished separately to the Admn. Deptt. well in time;
