Subject: - Release of funds of Capex Budget 2017-18 under Urban Development Sector.
Ref: - i. Planning Dev. & Monitoring Deptt's. Govt. Order No. 56-PD of 2017-Dated 09.02.2017.

**Government Order No: 204- HUD of 2017
Dated: 27.09.2017**

Sanction is hereby accorded to the release of **Rs. 40.00 Lacs (Rupees Forty Lacs)** only in favour of Deputy Commissioner/CEO, LAHDC, Leh/Kargil (**Rs. 20.00 Lacs each**) under the scheme "**Installation of Street Lights (LED)**" under Urban Development Sector of Capex Budget 2017-18 to be utilized during current financial year.

The release & subsequent utilization of funds is subject to the following conditions that: -

- i. the funds shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- ii. the funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- iii. the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract.
- iv. all codal formalities are strictly adhered to while booking the expenditure;
- v. the funds so released shall not be available for any re-appropriation/diversion.
- vi. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- vii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- viii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- ix. the expenditure shall commensurate with the physical progress achieved;
- x. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
