The release & subsequent utilization of funds is subject to the following conditions that:-

- i. The funds shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- ii. The funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates after following all codal formalities under rules, simultaneously, functioning of all defunct lights be ensured;
- iii. The warranty clause of 24 months from the date of installation shall be incorporated in the allotment of the contract;
- iv. the funds so released shall not be available for any re-appropriation/diversion;
- v. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- vi. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- vii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- viii. the expenditure shall commensurate with the physical progress achieved;
- ix. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
