Subject:-Release of funds as Central Share under Rajiv Awas Yojana during the year 2015-16.

Sanction is hereby accorded to release of funds amounting to Rs.126.15 lacs (Rupees One Crore Twenty Six Lakh & Fifteen Thousand) only in favour of Deputy Commissioner Leh as grant-in-aid on account of payment of additional central assistance (ACA) for Rajiv Awas Yojana(RAY)-Capital assets under JNNURM for its utilization during the year 2015-16.

However, the release of funds is subject to the completion of the following condition:-

- i. The funds shall be utilized for execution of scheme strictly as per originally approved components and according to Government of India's prescribed guidelines.
- ii. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities and as per the guidelines of Government of India for the scheme;
- iii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent Authority and as per the guidelines of the scheme.
- iv. The funds shall not be utilized on clearance of any past liability;
- v. The implementing agency shall ensure that there is no overlapping of funds for the works/ scheme being executed;
- vi. The expenditure shall commensurate with the physical progress achieved;
- vii. The physical and financial progress report for implementation of the project shall be furnished to the department in the prescribed form
- viii. The funds so released shall not be available for any re-appropriation/diversion;

The expenditure on this account shall be debited as per following classification for proper accounting:-

- Major Head: 4217-Central Outlay on Urban Dev.
- Sub-major Head: 03 IDSMT
- Minor Head: 800-Other Expenditure.
- Group Head: 011-State Plan
- Sub-Head: 2232-JNNURM-RAY


