Sanction is hereby accorded to the release of **Rs. 20.00 Lakh (Rupees Twenty Lakh)** only in favour of Commissioner Jammu Municipal Corporation under the scheme "**Capital City Development Project (CCDP)**" of Urban Development Sector of State Capex Budget 2017-18 to be utilized for "Construction of Lane/Drain opp. L. No. 19 Swaran Vihar, Jammu.

The Director, Finance shall draw the funds in advance from treasury through WDC bill and placed the same at the disposal of Commissioner, Jammu Municipal Corporation.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;
- (ii) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP or any other source;
- (iii) the funds so released shall be utilized for proper purpose and not to be benefited to any individual;
- (iv) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (v) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) the funds so released shall not be available for any re-appropriation/diversion;
- (vii) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
