In continuation to Govt. Order No. 184-HUD of 2016 dated 06.09.2016, sanction is hereby accorded to the release of funds to the tune of Rs. **50.00 Lacs (Rupees Fifty Lacs)** only in favour of **Project officer, Charar-i-Sharief Development Project** constituting 100% of the current year's approved allocation under the Scheme "**Charar-i-Sharief Development Project**" of Urban Development Sector thereby aggregating total releases to the extent of Rs.100.00 Lacs during the C.F.Y, to be utilized on approved works programme/Action Plan for the year 2016-17.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re-appropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) all video graphic/photographic evidence of works both shall be maintained.
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;


