Sanction is hereby accorded to the release of funds amounting to Rs.998.98 lacs (Rupees Nine Crores, Ninety Eight Lacs and Ninety Eight Thousand) only as grant-in-aid of 2014-15 under National Urban Livelihood Mission (NULM-Capital component) during the current financial year 2015-16 and its placement at the disposal of State Urban Development Agency for implementation of the NULM scheme.

The Director Finance Housing & Urban Development Department shall draw the funds in advance from Treasury through WDC bill and credit the same in the official Bank account of J&K SUDA bearing No:- 0110040100005976.

However, the release of funds is subject to the following conditions:-

1. The funds shall be utilized for the purpose these have been released.
2. No diversion/re-appropriation of funds so released is allowed.
3. The released funds does not confer the sanction for incur the expenditure which shall be booked after observing all codal formalities.
4. The funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guide lines.
5. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and, up to date cumulative expenditure and physical achievement.
6. The department shall send utilization certificates of the funds released, as early as possible, and definitely before 31-03-2016 to GOI, with a copy to Finance Department.

7. Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/Government of India's guidelines.
