The terms of reference of the Committee shall be to:

1. The Committee shall discuss, deliberate, consult and finalize the policy related to reuse of waste water in J&K State in conjunction with urban reforms requirement of ongoing AMRUT programme in J&K State.
2. The Committee shall meet all concerned stake holders, enforcement agencies, technology providers, financial experts, who shall provide their feedback on the scope of work to be included in draft of policy.
3. The Committee shall hold its regular meeting under the chairman of committee and submit the draft policy within 02 weeks from date of issuance of the Order.

4. The committee shall also look into the similar examples constituted elsewhere in the country and ensure that same is documented adequately in the policy.

The Committee may also co-opt members from any department/organization and may also invite experts in the field to participate in its deliberations.
