Sanction is hereby accorded to the appointment of Mr. Arun Kumar (KAS) Director Local Bodies Jammu, as Inquiry Officer to initiate an in-depth inquiry into the allegations of financial irregularities allegedly committed by S/Shri S.K. Wali the then Executive Engineer, Ravinder Koul the then JE and Kulbir Singh the then Store Keeper of Jammu Municipal Corporation (JMC) on the following points which have been raised by the Vigilance Organization J&K Jammu vide their letter No. VO/SP©-JSC-01/2013-14768-70 dated 20.11.2016 (Copy enclosed).

- a) The premixing laid has been found damaged in full and has not served the purpose.
- b) The estimate of the works executed has not been found technically sanctioned, which amounts to violation of codal procedures.
- c) Premixing does not exist on ground. The lanes were found having good quality of premixing coat below the sub-standard coat.
- d) The statement of JMC shows that Tar has been issued even after laying of premixing in the lanes which is absolutely doubtful.
- e) A loss of Rs. 185200/- has been suffered by the State exchequer on account of Tar issued by the JMC Jammu in favour of contractor which otherwise has not been utilized on ground.
- f) No action stands initiated by JMC against the suspect contractor like forfeiture of his CDR, blacklisting etc.

The Inquiry officer shall submit the report within 30 days positively alongwith his recommendations.
