In continuation to Govt. Order No. 200-HUD of 2017 dated 15.09.2017, sanction is hereby accorded to the release of funds to the tune of Rs. **87.50 Lacs (Rupees Eighty Seven Lakh & Fifty Thousand)** only representing balance 50% of approved allocation in favour of Managing Director, J&K Housing Board, of Capex Budget 2017-18 under "Housing Sector" to be utilized on approved ongoing scheme/works as per the breakup of funds given here under: -

The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of MD, J&K Housing Board, Jammu immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the Director Finance/Joint Director (P&S) of the Deptt. Shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed, from any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

- (vii) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time , i.e 5th of succeeding month;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
