The above appointee(s) shall report to the Additional Secretary to the Government, Housing & Urban Development Department within a period of 21 days from the date of issuance of this order. In case, of failure to join within the stipulated period, his/their appointment shall be deemed to have been cancelled without any further notice.

The appointee(s) shall be allowed to join only on production of the following certificates in original:

- i. Academic/Technical Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Permanent Resident Certificate issued by the Competent Authority.
- v. Certificates from the Director Industries Centre (DIC) and District Employments & Counselling Centre to the effect that no loan under self-employment scheme has been taken by the appointee(s).
- vi. Reserved category certificates (in case of candidates belonging to reserved categories).

The appointment of the above candidates as Assistant Architects in the J&K Architects Organization (Gazetted) Service shall further be subject to the following conditions:-

- i. Each appointee shall give an undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the office of the Inspector General of Police, CID, J&K, to whom a reference shall be made by the Housing & Urban Development Department, he shall have no right to claim his appointment as Assistant Architect, in the J&K Architects Organization Service and his appointment as such, shall be deemed to have been cancelled ab-initio;
- ii. Verification/genuineness of the qualification, reserved category certificates (wherever applicable) and recognition of the Institutes from the concerned issuing authorities.

The Salary of the appointees shall not be drawn and disbursed unless the satisfactory reports in respect of (i) and (ii) above are received in their favour. The appointee(s) shall be on probation for a period of two years. The appointment of the candidates shall be subject to outcome of the writ petitions if any pending before any Competent Court of Law.
