Sanction is hereby accorded to the release of **Rs. 150.00 Lacs (Rupees One Crore & Fifty Lacs)** only in favour of **J&K State Urban Development Agency** as State Share for the Centrally Sponsored Scheme of NULM under State Capex Budget 2016-17 for meeting the State Share against central funds of NULM.

The Director, Finance, H&UDD shall draw the funds in advance from treasury through WDC Bills and credit the same in the official bank account of Member Secretary J&K SUIDA bearing No. 01100401000005976 for further releases to implementing Agency/s.

The release & subsequent utilization of funds is subject to the following conditions that: -

- i. the agency shall transfer the funds to the implementing agency immediately as per the financial pattern in the guidelines of GoI, for the programme under NULM and for the specific purpose for which it has been released;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority and as per the guidelines of the scheme;
- iv. the funds shall be utilized on the approved components of the Mission;
- v. the funds so released shall not be available for any re-appropriation/diversion;
- vi. the expenditure shall commensurate with the physical progress achieved.
- vii. the Director Finance, of the department shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- viii. the UCs for the released amount shall be submitted to the department within the stipulated time;
- ix. all the UCs/Red accounts of advance drawls shall be rendered to the concerned quarters;
- x. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
