Subject: - Release of funds of Capex Budget 2016-17 under Urban Development Sector.

Sanction is hereby accorded to the release of **Rs. 15.00 Lacs (Rupees Fifteen Lacs)** only in favour of **Director Urban Local Bodies, Kashmir** out of the available funds of Capex Budget 2016-17 to be utilized for execution of different developmental works in MC Dooru Veri Nag during the year 2016-17 to be prioritized in consultation with the public representatives of the area.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the execution of the works be taken up after seeking formal approval of the works so identified/prioritized from the Administrative Department;
- (iii) the funds shall be utilized on those components of the schemes only which have been Technically sanctioned and Administratively approved by the Competent Authority;
- (iv) the funds shall be utilized on the approved schemes/works only and no new scheme shall be taken up without the approval of the Competent Authority;
- (v) the implementing agency/s shall ensure that the work should be executed on e-tendering mode;
- (vi) the funds shall not be utilized on clearance of past liability, repair, renovation and Maintenance work and the works should not have been executed during last 5 years;
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source Such as SDRF/State Plan/District Plan /CSS/Flag Ship Programme or any other source;
- (viii) the funds so released shall not be available for any re-appropriation/diversion;
- (ix) the expenditure shall commensurate with the physical progress achieved;
- (x) all video graphic/photographic evidence of works both shall be maintained;
- (xi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;

- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
