- (iv) the expenditure shall commensurate with the physical progress achieved;
- (v) all video graphic/photographic evidence of works both shall be maintained;
- (vi) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (vii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
