In continuation to Govt. Order No. 02-HUD of 2016 dated 06.01.2016, sanction is accorded to the release of **Rs.25.00 lacs (Rupees Twenty Five lacs)** only, in favour of **Commissioner Municipal Corporation, Srinagar** under the Scheme "Capital City Dev. Programme" of Urban Development Sector - Capex Budget 2015-16 to be utilized on approved Action Plan/Works Programme during the year 2015-16, thereby aggregating the total releases to the extent of Rs. 100.00 lacs made so far under the scheme in favour of Commissioner Municipal Corporation Srinagar.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of SMC in the shape of Hundi.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only.
- (iv) the funds so released shall not be available for any re-appropriation/diversion.
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the Director Finance of the Deptt. shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (vii) the Utilization Certificate of the amount is rendered to the concerned quarters within the stipulated time;

- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) that all video graphic/photographic evidence of works both pre-execution & post execution shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority


