In continuation to Govt. Order No. 62-HUD of 2018 dated 23.02.2018, sanction is hereby accorded to the release of funds to the tune of Rs. 16.00 Lacs (Rupees Sixteen Lakh) only in favour of Vice Chairman, Jammu Development Authority/Vice Chairman, Srinagar Development Authority (Rs. 8.00 Lacs each) under the scheme Preparation of Master Plan of Capex Budget 2017-18 under "Urban Development Sector" to be utilized for "preparation of Master /Zonal Plans of Jammu and Srinagar cities", thereby, aggregating total releases to the extent of Rs. 50.00 Lakh (Rs. 25.00 Lakh each) during current financial year.

The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Vice Chairman, JDA/SDA immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;

- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time, i.e. 5th of succeeding month;

 (ix) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
