Subject: - Release of funds of Capex Budget 2016-17 under Urban Development Sector.

Ref: - Planning Dev. & Monitoring Deptt's. Govt. Order No.270 -PD of 2016 Dated 20.09.2016 and authorized vide communication No. PD/2016-17/Coord-101/01-A dated: - 15.11.2016.

Government Order No: 74 - HUD of 2017 Dated: 20-03-2017

In continuation to Govt. Order No. 178-HUD of 2016 dated 16.08.2016, sanction is here by accorded to the release of *Rs. 25.00 Lac (Twenty Five Lacs) only in favour of Commissioner, Municipal Corporation Jammu* under the scheme "Street Lights (LED)" under Urban Development Sector of State Capex Budget 2016-17.

The Director, Finance H&UDD shall draw the funds in advance from treasury through WDC bills and place the same at the disposal of concerned corporation immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the funds shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- the funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- the proper inventory of lights installed in each Municipal ward/area shall be kept and the new lights to be installed shall be properly marked with serial number and date of installation.
- iv. the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract;
- v. all codal formalities are strictly adhered to while booking the expenditure;
- vi. the funds so released shall not be available for any reappropriation/diversion.
- vii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- viii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- ix. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- x. the expenditure shall commensurate with the physical progress achieved;
- xi. the physical and financial progress report containing the No. of LED lights installed ward –wise shall be furnished to the Admn. Deptt. on monthly basis well in time;
