Sanction is hereby accorded to the release of Rs. 70.00 Lacs (Rupees Seventy Lacs) only in favour of Director Urban Local Bodies, Jammu for its further placement at the disposal of Collector Land Acquisition Reasi out of State Capex Budget of 2016-17 for Acquisition of Land on account of compensation as per final award for "Construction of Road from Takeup Point from Railway Road Katra near Katra Development Authority Office to Village Arli, Hamsali"

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the shajra khasra of the land to be acquired shall be authenticated by the competent authority and as per the final award issued by the land collector;
- (ii) the cost of land to be acquired for the purpose shall be a part of project cost;
- (iii) all codal formalities are strictly adhered to while booking the expenditure and making the payment of compensation to the land owners;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
