Sanction is hereby accorded to the withdrawal of funds amounting **Rs. 25.00 Lakh (Rupees Twenty Five Lakh)** only released vide Govt. Order No. 29-HUD of 2018 dated 23.1.2018 in favour of Director urban Local Bodies, Jammu for execution of work viz; **“Construction of Auditorium at Kishtwar”** in MC Kishtwar of Urban Development Sector- State Capex Budget 2017-18.

Consequent to above withdrawal, sanction is also hereby accorded to the release of funds to the tune of Rs. 25.00 Lakh (Rupees Twenty Five Lakh) only in favour of District Development Commissioner, Kishtwar for execution of the work namely “Construction of Auditorium at Kishtwar” for its further placement at the disposal of Superintending Engineer, PWD (R&B) Circle Doda/Kishtwar under Urban Development Sector- State Capex Budget 2017-18.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii. the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode and the balance funds shall be released after submission of completion / functionality certificate to the department if any;
- iii. the physical verification of the works be conducted by the Senior Officer hierarchy to ascertain ground existence, quality parameters and execution as per approved detailed estimates as well as benefit to the public;
- iv. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- v. The implementing agency shall ensure that the works should not have been executed from last five years & also ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vi. the funds so released shall not be available for any re-appropriation/diversion;

- vii. the expenditure shall commensurate with the physical progress achieved;
- viii. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- ix. the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;


