Sanction is hereby accorded to the release of funds amounting to Rs. 500.00 Lacs (Rupees Five Hundred Lacs) only in favour of Managing Director, J&K Housing Board, of Capex Budget 2016-17 under Housing Sector to be utilized as Matching State Share for "Housing For All" (HFA) scheme during current financial year.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of MD, J&K Housing Board, Jammu.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the MD, J&K Housing Board shall disburse the funds as per the financial (i) pattern in the guidelines of GoI for the programme under Housing for All (HFA) and for the specific purpose for which it has been released;
- the release of funds does not confer the sanction to incur the expenditure (ii) which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which (iii) have been technically sanctioned and administratively approved by the Competent Authority and as per the guidelines of the scheme;
- the funds so released shall not be available for any re-appropriation/diversion; (iv)
- the implementing agency shall ensure that there is no overlapping of funds for (v) the works being executed from any other source such as SDRF/State Capex Budget/District Capex Budget/CSS/BADP/ Flagship Programme or any other source;
- the expenditure shall commensurate with the physical progress achieved; (vi)
- that all video graphic/photographic evidence of works both pre-execution and (vii) post execution shall be maintained;
- the physical and financial progress report shall be furnished to the Admn. (viii) Deptt. Well in time;
- no expenditure shall be incurred against Revised Cost which has not been (ix) approved by the Competent Authority;
- the implementing agency shall vouchsafe the utilization of funds as per codal (x) procedure/guidelines in vogue;
- all the Utilization Certificates/ Red Accounts of advance drawal shall be (xi) rendered to the concerned quarters;
