Sanction is hereby accorded to the release of funds amounting to <u>Rs.</u> 100.00 Lacs (Rupees One Hundred Lac) only in favour of <u>Managing Director</u>, J&K <u>Housing Board</u>, of Capex Budget 2016-17 under the scheme <u>"Construction of Community/Town Halls of Housing Sector"</u> to be utilized for <u>"Construction of Syed Janbaz Wali Memorial Community Centre Baramulla"</u> under Housing Sector to be utilized during current financial year.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of MD, J&K Housing Board, Jammu.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source such as SDRF/State Capex Budget/District Capex Budget/CSS/BADP/ Flagship Programme or any other source;
- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- (vii) the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time;
- (viii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
- (ix) the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines in vogue;
- (x) all the Utilization Certificates/ Red Accounts of advance drawal shall be rendered to the concerned quarters;
