Sanction is accorded to the release of Rs. **200.00 lacs (Rupees Two Hundred lacs) only** in favour of Mission Director Smart City Mission to be utilized for preparation of Smart City Proposals ( SCPs) of Jammu & Srinagar cities under Smart City Mission (SCM).

The Director Finance, H&UDD shall draw the funds in advance from Treasury through WDC Bill and credit the same in the official Bank of Mission Director AMRUT bearing A/c No. 0110040500000061 for its further utilization as per the guidelines/norms of the Mission.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority & as per the guidelines of the Mission.
- (iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) the Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/guidelines.
- (vii) the Utilization certificate for the released amount shall be submitted to the Department within the stipulated time;
