Sanction is here by accorded to the release of funds to the tune of **Rs. 470.94 Lacs (Four Crore Seventy Lacs and Ninety Four Thousand only)** along with Advance Drawl in favour of Chief Executive Officer, J&K State Urban Infrastructure Development Agency (SUIDA) for its further placement to the Director, Urban Local Bodies, Jammu for its utilization on Integrated Housing & Slum Development Programme (JnNURM)-Capital Assets as Additional Central Assistance released by the MoHUPA, GoI vide aforementioned reference for its utilization of approved IHSDP projects, a component of JnNURM during the financial year 2016-17 as per the breakup given at Annexure 'A' to this Government Order.

The Director, Finance H&UDD shall draw the funds in advance from treasury through WDC bills and place the same at the disposal of Chief Executive Officer, J&K State Urban Infrastructure Development Agency (SUIDA) immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the CEO, SUIDA shall transfer the funds to the Implementing Agency after ensuring that the physical progress commensurate with the financial expenditure and also the execution of the scheme has been done strictly as per the approved project report;
- ii. the funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the Competent Authority;
- iii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- iv. the implementing agency shall ensure that there is no overlapping of funds from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. etc;
- v. the funds so released shall not be available for any re-appropriation/ diversion at any level;
- vi. all video graphic/photographic evidence of works both shall be maintained.
- vii. the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- viii. no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority;
- ix. the Utilization Certificate for the release amount shall be submitted to this department within time;

- x. the Director Finance of the department shall vouchsafe the utilization of funds as per codal procedure/guidelines;
