Sanction is accorded to the release of funds to the tune of **Rs. 20.00 Lakh (Rupees Twenty Lakh)** only in favour of Chief Engineer, J&K UEED under Sewerage Sector of State Capex Budget for the year 2017-18 as an additionality for clearance of work done liability on account of construction of Sewer at Munawarabad.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. The release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- ii. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iii. The funds shall be utilized on the approved components of the project/ schemes only and no new work/scheme shall be taken up without the approval of the competent authority;
- iv. The implementing agency shall ensure that the liabilities are legitimate and the work for which liabilities were incurred was/is part of a approved DPR, executed under proper authority and after observing all codal requisite formalities and due procedures and also ensure that the work has not been billed and / or paid for under any state /central or other schemes earlier.
- v. The implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source;
- vi. The funds so released shall not be available for any re-appropriation/diversion;
- vii. The expenditure shall commensurate with the physical progress achieved;
- viii. All video graphic/photographic evidence of works both shall be maintained;

- ix. The physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- x. No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
