In continuation to Government Order No:- 87-HUD of 2015, dated:-20.03.2015, Sanction is hereby accorded to the release of funds amounting to Rs.14.00 lacs (Rupees Fourteen Lacs) only in favour of Director Urban Local Bodies Jammu for Construction of Community Halls under Housing Sector thus raising total allotment to Rs.44.00 lacs during current year 2014-15 under the instant head.

However, the release of funds is subject to the completion of the following condition:-

- i. The funds shall be utilized only those components of the schemes which have been technically sanctioned and administratively approved by the competent Authority as per the CAS-MIS format;
- ii. The executing agency shall ensure that there is no overlapping of funds for the works being executed;
- iii. The executing agency shall furnish physical/financial progress report to this department by or before 5th of every month;
- iv. The funds so released shall not be available for any re-appropriation/diversion;
- v. The utilization certificate for the released amount shall be submitted to this department at the end of March 2015;

The expenditure on this account shall be debited as per following classification for proper accounting:-

- Demand No: 19
- Major Head: 4217-Capital outlay on Urban Development.
- Minor Head: 800-Other Expenditure.
- Group Head: 0011-State Plan Normal.
- Sub-Head: 0893 Other Housing Schemes.
