Sanction is here by accorded to the release of funds amounting to **Rs. 80.00 Lacs (Rupees Eighty lacs) only** in favour of **Director Urban Local Bodies Jammu under the scheme Emergent Public Demands of Drainage Sector - State Capex Budget 2017-18** for its further placement at the disposal of Executive Engineer Town Drainage Jammu under Drainage Sector to be utilized for clearance of workdone liability of the ongoing/approved Drainage schemes during Current Financial Year.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) The implementing agency shall ensure that the liabilities are legitimate and the work for which liabilities were incurred was/is part of a approved DPR, executed under proper authority and after observing all codal requisite formalities and due procedures and also ensure that the work has not been billed and / or paid for under any state /central or other schemes earlier;
- (iii) The priority must be given to the works which are nearing completion and HCMs commitments shall be first charge over the current releases
- (iv) The implementing agency shall ensure that the 1st charge be given to the those works/schemes for which the department has already conveyed the authorization for execution of works during 2017-18 from time to time;
- (v) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other sources such as SDRF, District Plan, CSS, BADP, PM's Package, CDF, MPLADS. etc.;
- (vi) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vii) the funds so released shall not be available for any re-appropriation any diversion from one component to another component;
- (viii) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained;
- (ix) the Utilization Certificates for the released amount shall be submitted well in time;

- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against revised cost which has not been approved by the Competent Authority.
