In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22-02-1994, read with SRO-177 dated 20-6-2014, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Mudasir Ahmad Sheikh S/O Late Mohd Sultan Sheikh (Ex. Orderly) R/O Aluchi Bagh, Srinagar as Class-IV in the pay scale of Rs. 4440-7440 with the grade pay of Rs. 1300/- in the J&K Urban Environmental Engineering Department, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall report to the J&K Urban Environmental Engineering Department, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents / certificates to be verified subsequently:-

- i. Academic Qualification Certificate
- ii. Age and Health certificate.
- iii. Permanent Resident Certificate
- iv. Dependent Certificate issued by the Assistant Commissioner, revenue
- v. All other relevant documents as are required under SRO-43/1994
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years, if, of verification the certificates produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police CID, to whom a reference shall be made by the Chief Engineer, J&K Urban Environmental Engineering Department.
