Sanction is accorded to the release of Rs 25.00 lacs (Rupees Twenty Five lacs only) with the break-up of Rs. 12.50 lacs each in favour of Director Urban Local Bodies, Kashmir and Director Urban Local Bodies, Jammu, under the scheme of "Construction of Community/Town Halls" of Housing Sector - Capex Budget 2016-17 to be utilized for approved Action Plan of Current Financial Year i.e. 2016-17.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the scheme only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any re-appropriation /diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved and all video graphic/photographic evidence of works both shall be maintained.
- (vii) the UCs for the released amount shall be submitted well in time ;
the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
