Sanction is here by accorded to the release of funds to the tune of **Rs. 44.17 Lac (Forty Four Lacs and Seventeen Thousand only)** along with advance drawl in favour of **Managing Director, J&K Housing Board, Srinagar** for establishment of City Level Technical cell under PMA-HFA (U).

The Director, Finance H&UDD shall draw the funds in advance from treasury through WDC bills and place the same at the disposal of concerned organization immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the funds shall be utilized with the terms and conditions Strictly as per the guidelines of PMA-HFA (U);
- ii. the State Nodal Officer of HFA shall strictly monitor the progress of the preparatory;
- iii. the Utilization Certificate shall be furnished as per the prescribed format devised by GoI before claiming next installment;
- iv. all codal formalities are strictly adhered to while booking the expenditure;
- v. the funds so released shall not be available for any re-appropriation/diversion.
- vi. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- vii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

- viii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- ix. the expenditure shall commensurate with the physical progress achieved.
