3. The quantum of works already executed and the expenditure incurred for execution of these works.
4. Measurement of the work already executed on site and the quantam of work still required to be undertaken for completion alongwith its estimates/projected cost.
5. To verify & check the DPR prepared by JDA to complete the balance work.
6. Any other issue which the committee may like to report in their findings.




