- i. the details works programme against these funds released be submitted to the department before further release of funds;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

- iv. the funds shall not be utilized on clearance of any past liability, repair and maintenance work.
- v. the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the expenditure shall commensurate with the physical progress achieved;
- viii. all video graphic/photographic evidence of works both shall be maintained.
- ix. the funds under Street Lights shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- x. the funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- xi. the proper inventory of lights installed in Municipal ward/area shall be kept and the new lights to be installed shall be properly marked with serial number and date of installation.
- xii. the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract.
- xiii. all codal formalities are strictly adhered to while booking the expenditure;
- xiv. the Administrator/Executive Officer MC, Kargil/Leh shall ensure the submission of physical and financial progress report to the Administrator Department well in time.
