Sanction is hereby accorded to the release of **Rs. 12.50 Lacs (Rupees Twelve Lac & Fifty Thousand)** only in favour of **Vice Chairman, Jammu Development Authority** as additionality under Capex Budget 2016-17 to be utilized for "Construction of Parking at Maharaja Hari Singh Park, Jammu during the current financial year 2016-17.

The Director Finance H&UDD shall draw the funds in advance through WDC bill and place the same at the disposal of *Vice Chairman, Jammu Development Authority*.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the funds shall not be applicable for utilization for clearance of the past liability.
- (ii) that there should be no over lapping of funds from any other source such as SDRF/District Plan/CSS/Flagship Programme/BADP or any other source.
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities.
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority.
- (v) the funds so released shall not be available for any re-appropriation/diversion.
- (vi) the Utilization Certificate for the released amount shall be submitted to the Department.
- (vii) all the UCs/Red Accounts of advance drawls shall be rendered to the concerned quarter.

- (viii) the expenditure shall commensurate with the physical progress achieved.
- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained.
- (x) the work shall be for the benefit of general public of the area and not to the interest of any individual.
