sanction is hereby accorded to the release of funds to the tune of Rs. 200.00 Lacs (Rupees Two Hundred Lacs) only with the break-up of Rs. 100.00 Lacs each in favour of Superintending Engineer, Drainage Circle SMC/JMC of Capex Budget 2016-17 under Drainage sector for its further placement at the disposal of concern Executive Engineers of respective Divisions to be utilized on the approved ongoing works.

The release & subsequent utilization of funds is subject to the following conditions that;

- the funds shall be placed at the disposal of Subordinate Executing (i) Agencies within seven days from the issuance if the Govt. order and copy endorsed to the Administrative Department.
- the release of funds does not confer the sanction to incur the (ii) expenditure which should be booked only after observing all codal formalities;
- the funds shall not be applicable for utilization for clearance of the (iii) past liability.
- the funds shall be utilized on those components of the schemes only (iv) which have been technically sanctioned and administratively approved by the Competent Authority;
- the funds shall be utilized on the ongoing schemes/works only and (v) no new scheme shall be taken up without the approval of the competent authority;
- the implementing agency shall ensure that there is no overlapping of (vi) funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- the funds so released shall not be available for any re-(vii) appropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- all video graphic/photographic evidence of works both shall be (ix) maintained;
- the physical and financial progress report shall be furnished to the (x) Admn. Deptt. well in time;

(xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
