In continuation to Government Order No 84-HUD of 2019 dated 18.03.2019, sanction is hereby accorded to the release of Rs.2.00 Crore (Rupees Two Crore)only alongwith advance drawl in favour of Chief Engineer, J&K Urban Environmental Engineering Department (UEED) as 2nd installment of matching share for implementation of the project of "Pollution Abatement of rivers Devika and Tawi at Udhampur under National River Conservation Plan( NRCP) for its utilization during Current Financial Year.

The Director Finance H&UDD shall draw the funds in advance from the Treasury through WDC Bill and deposit the same in the official Bank A/c of Chief Engineer J&K Urban Environmental Engineering Department operated by CE, J&K UEED and Accounts Officer, J&K UEED bearing Account No. 0110040510000024 maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar for its utilization as per the guidelines of the Scheme."

The release & subsequent utilization of funds is subject to the following conditions that:-

the release of funds does not confer the sanction to incur the expenditure which should i) be booked only after observing all codal formalities;

the funds shall be utilized strictly in accordance with the Guidelines of the scheme and ii) for the purpose for which it has been sanctioned and as per the terms and conditions of GoI sanction Letter No.: J-27023/1/2016-NRCD-II Dated: 25.11.2020 and Govt. Order No.: 08-HUD of 2021 Dated: 25.01.2021;

the funds shall be utilized for execution of the scheme strictly as per originally iii) approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;

the implementing agency shall ensure that there is no overlapping of funds for the iv) works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Languishing (JKIDFC)/Flagship programme or any other source;

the funds so released shall not be available for any re-appropriation/diversion; V)

the expenditure shall commensurate with the physical progress achieved, besides, the vi) ensure that the Utilization Certificates shall be submitted to the concerned quarter within the stipulated time;; vii)

the funds shall not be parked idle in the bank account;

the implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;

that all video graphic/photographic evidence of works both pre-execution and post ix) execution shall be maintained;
