Sanction is here by accorded to the release of funds amounting to **Rs. 10.00 Lakh (Rupees Ten Lakh) only** in favour of **Director, Urban Local Bodies Jammu** for clearance of work done claims on account of work namely "**Constt. of deep covered drain from H/o Vidya Rattan to Shammi Shop and other allied works at W.No.15, Patel Nagar, Kathua**" under the scheme "**Special Infrastructure Dev. of Distt. Headquarters / Major Towns**" of State Capex Budget 2018-19 of Urban Development Sector occurred under Hon'ble CM's commitment in MC Kathua.

The release & subsequent utilization of funds is subject to the following conditions that:-

- i. the funds be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance if the Govt. order and copy endorsed to the Administrative Department;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iv. the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- v. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vi. the funds so released shall not be available for any re-appropriation/diversion;
- vii. the expenditure shall commensurate with the physical progress achieved;
- viii. all video graphic/photographic evidence of works both shall be maintained;

- ix. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- x. no expenditure shall be incurred against revised cost which has not been approved by the competent authority.


